SULLY COUNTY BOARD OF COMMISSIONERS JANUARY 7, 2014

The Board of Sully County Commissioners held the first regular meeting in 2014 on Tues Jan 7, 2014 at 8:30 AM with members William Floyd, Jerry Richards, Judith Pullman, Beverly Zebroski & Joe Fanger present. Absent: none. ORGANIZATION OF BOARD: The first order of business was the selection of Chairman and Vice-Chairman for 2014. Commissioner Pullman moved that the 2013 Chairman, Bill Floyd & Vice Chairman, Jerry Richards remain the same for 2014. Second-Fanger. Unanimous vote aye.

<u>LEGAL</u>: States Attorney Emily Sovell, met with the Bd to go over Co legal matters.

FEE SCHEDULE: Planning & Zoning Director, Karen Wilcox, presented a fee schedule that was approved by the Planning and Zoning Bd as an amendment to the Planning & Zoning Ordinance. Wilcox noted that the Sully County Zoning Ordinance requires a building permit for all areas of Sully County, excluding property within the Onida City limits and excluding property within the Agar Town limits, before any building or other structure to be erected, moved, added to or changed in use. Wilcox noted that this would amend the zoning ordinance by setting a fee schedule to be included in the ordinance. Discussion followed by the Bd, DOE & States Attorney Sovell. Moved by Zebroski, seconded by Richards to amend the Planning & Zoning Ordinance by giving first reading to the fee schedule as presented. Motion carried 4-1 with Fanger voting nay. Bd directed Aud McGee to print in full the proposed fee schedule & second reading date.

<u>ABATEMENT</u>: Karen Wilcox, DOE, presented an abatement for Mary Bentley, whose trailer was moved & 2014 taxes were paid at the time of removal. Moved by Fanger, seconded by Pullman to abate taxes in the amt of 399.18. Unanimous vote aye.

For those County residents who die in a state of indigence or who are otherwise qualified under SDCL 28-17 BE IT RESOLVED Sully County shall allow burial and funeral expenses as follows:

- 1. Funeral-----3000.00
- 2. Liner if required------Included in funeral cost
- 3. Cremation------ 2000.00
- 4. No mileage allowed.

Any requests for County burial assistance shall be made prior to the services, whenever practical. It shall be the duty of the Commissioner in whose district the decedent had established residency to determine if the resident was indigent at the time of death if it is not possible for the entire Board to meet prior to the time of the internment.

Be it resolved that the Sully County Commissioners will follow all guidelines set out in Sully County's Welfare Guidelines for burial assistance as per Appendix D of the Welfare Guidelines for Sully County.

BE IT FURTHER RESOLVED, these amounts shall be for the year 2014.

WHEREAS it is necessary that a resolution be passed authorizing attendance of such meetings and payment of expenditures to said meetings and workshops, and

WHEREAS the Sully County Board of Commissioners set the mileage and conference expense for the county offices.

NOW THEREFORE BE IT RESOLVED Sully County will pay up to \$26.00 per day for meals. AMENDED CONTRACT WITH GAME & FISH: Moved by Richards, seconded by Fanger to approve amending Agreement #2012-59-04 with the Game, Fish & Parks to read: The "Total Not to Exceed" amount is increased from \$3000.00 to \$4000.00 per calendar year for the remainder of the life of the AGREEMENT. Unanimous vote aye. GRANT AWARD: Helen Jane Paxton & Curt Olson, met with the Bd to advise them that Sully County has been awarded a grant through the South Dakota Broadband Initiative, facilitated by the SD Bureau of Information & Telecommunications with funding provided by the United States Department of Commerce's National Telecommunications and Information Administration. Olson & Paxton explained there is an in-kind match consisting of a proposed amount of 2124.08. Moved by Richards, seconded by Zebroski to accept the grant at a cost share to the Co. Unanimous vote aye.

<u>PURCHASE</u>: Aud McGee requested approval for the purchase of a new desk for her office along with a credenza for storage of election supplies. GENERAL FUND CASH BALANCE REPORT: Aud McGee presented the General Fund Surplus Analysis for the Co as of December 31, 2013 for Bd review. The unreserved, undesignated fund balance, in the general fund may not exceed forty percent of the total amount of all general fund appropriations contained in the budget for the next fiscal yr. Sully Co's analysis as of December 31, 2013 shows a 27.61% fund balance percentage. Moved by Zebroski, seconded by Pullman to approve the report. Unanimous vote aye.

2013 INVENTORIES: The Bd reviewed office inventories for 2013.

ANNUAL REPORT: Sully Co Register of Deeds annual report was reviewed by the Bd & placed on file.
