## SULLY COUNTY BOARD OF COMMISSIONERS MAY 6, 2014

The Board of Sully County Commissioners held their regular scheduled mtg on Tues, May 6, 2014. Chmn Bill Floyd called the mtg to order. Other members present: Jerry Richards, Judy Pullman, Joe Fanger & Beverly Zebroski. MINUTES: Moved by Zebroski, seconded by Pullman to approve the Commissioners minutes of 4/1 & 4/8 & the Consolidated Board of Equalization & County Board of Equalization minutes of 4/8. Unanimous vote ave. SPEED LIMIT CHANGE: Sheriff Bill Stahl met with the Bd. Stahl asked the Bd to consider a speed limit reduction beginning near the intersection of US Highway 83 & 185th Ave heading in an easterly direction through Onida. Stahl presented his recommendation in written format for Bd consideration. States Attorney Sovell was also present. After lengthy discussion it was moved by Fanger, second by Zebroski to give first reading to amend Ordinance 2005-1, an ordinance establishing speed zones to read as follows: Beginning near the intersection of US Highway 83 & 185th Street heading in an easterly direction for 3/10ths of a mile the speed limit shall be 45 miles per hour. For 2/10th of a mile from the intersection near Ash Avenue (185th Street) and 4th Street to the intersection near Ash Avenue (185th Street) and 5th Street the speed limit shall be 30 miles per hour. For 4/10ths a mile from the intersection near Ash Avenue (185th Street) and 5th Street to the intersection near Ash Avenue (185th Street) and 11th Street thru Onida the speed limit shall be 20 miles per hour. For the next 10 miles from the intersection near Ash Avenue (185th Street) and 11th Street to the intersection near 185th Street and 315th Avenue the speed limit shall be 65 miles per hour with a speed limit of 55 miles per hour for trucks 10,000 pounds and over. Unanimous vote ave. Second reading will be held on June 5, 2014. EXECUTIVE SESSION: Moved by Richards, second by Fanger to go into executive session per SDCL 1-25-2 (3). Unanimous vote aye. Moved by Fanger, seconded by Pullman to come out of executive session. Unanimous vote aye. POOR RELIEF Motion by Zebroski, , second by Floyd to settle County Poor Relief Claim # MM as follows: In exchange for payment of \$15,000.00 by obligor on or before July 15, 2014, the County will release its lien and consider the obligation paid in full. Unanimous vote aye.

EASEMENT: Moved by Richards, second by Floyd to file with the Sully County Register of Deeds the easement for public right of way executed by Steffen Brothers, Inc., and the County in relation to the County road right-of-way 60 feet in width, beginning on SD Highway 1804 approximately two thousand seven hundred feet (2700') south of the intersection of 192nd Street and SD Highway 1804, running west two thousand six hundred feet (2600') to the intersection of the platted Okobojo Heights road Yucca Ridge Trail and Fort Sully Trail, following Fort Sully Trail through the SW ¼ of 15-113-80 and SE ¼ of 16-113-80 approximately five thousand five hundred feet (5500'). Unanimous vote aye.

<u>POOR RELIEF</u>: Moved by Richards, second by Fanger to deny a request from St Mary's Hospital for 1 because the individual did not meet Co poor relief guidelines. Unanimous vote aye.

<u>PLAT</u>: Karen Wilcox, DOE, met with the Bd & presented a plat for Bd approval. Wilcox noted that the Planning & Zoning Bd approved the plat at their meeting held on May 5. Moved by Pullman, second by Floyd to approve Resolution 2014-7. Unanimous vote aye.
