RESOLUTION 2018-9

FEDERAL LAND ACCESS PROGRAM GRANT

WHEREAS, Sully County has identified the need to undertake reconstruction of the Little Bend Road/185th Street located 18 miles west of US Hwy 83 at Onida; and

WHEREAS, the Sully County Board of Commission recognizes that the Little Bend Road/185th Street is a highly traveled road that leads to various high-use recreation sites along Lake Oahe;

WHEREAS, Sully County is eligible to apply for Federal Land Access Program Grant funds for the proposed reconstruction to the road because it is an access road to federal land;

WHEREAS, Sully County agrees to provide at least a 17.18% local match for eligible costs associated with said project; and

NOW THEREFORE BE IT RESOLVED, that the Sully County Board of Commission does hereby authorize the Chairman of the Sully County Board of Commission to sign and submit a Federal Land Access Program Grant application, requesting up to 82.82% of the eligible costs for said project.
