The Board of Sully County Commissioners held their regular scheduled mtg on Thurs, July 8, 2021. Chmn Yackley called the mtg to order at 7:30 am. <u>ADOPT AGENDA</u>: Motion by Floyd, second by Shepherd to adopt the agenda with the addition of SDDOT Bridge Replacement & Rehabilitation Funding Agreement Amendment #1. Unanimous vote aye.

PUBLIC COMMENT: No one was present for public comment.

<u>REQUEST TO VACATE ROAD</u>: Curt Mundt met with Bd to discuss 296th Ave beginning at the intersection of 172nd St south 3/8 of a mile. Bd agreed to hold No Maintenance Hearing on Aug 3rd.

STEP INCREASE: Deputy Hight will receive a 3rd year \$.10/hr step increase on July 22nd.

Resolution Establishing Minimum Maintenance Road

WHEREAS, SDCL 32-12-46 allows the Sully County Board of Commissioners to designate any road on the county highway system as a minimum maintenance road if the Board determines that the road or a segment of the road is used

only occasionally or intermittently for passenger and commercial travel;

WHEREAS, SDCL 32-12-46 allows a minimum maintenance road to be maintained at a level less than the minimum standards for full maintenance roads, but shall be maintained at the level required to serve the occasional or intermittent traffic;

WHEREAS, SDCL 32-12-47 states that signs shall be posted on the minimum maintenance road notifying the motoring public that it is a minimum maintenance road and that the public travels on the road at its own risk.

NOW THEREFORE BE IT RESOLVED that the Sully County Board of Commissioners has designated two (2) miles of 308th Avenue in Rich Valley Township beginning at the intersection of 182nd Street located in SW corner of Section 21-115N-76W proceeding north and ending at the intersection of 180th Street located in NW corner of Section 16-115N-76W to be declared a minimum maintenance road and will be posted as such.

<u>SUTTON BAY ROAD</u>: Fred Nadeau from Sutton Bay & Derek McTighe from Brosz Engineering updated Bd on Sutton Bay Road. Road district formation is progressing. Aud Lamb will contact Legislative Audit to see if there would be any issues with County administering road project & receive funding reimbursement from DOT & GF&P prior to road district being formed.

<u>LITTLE BEND ROAD</u>: Harold Doer discussed road with Bd. Doer wondered about DOT funding that might be available instead of waiting for SDFLAP Grant. Federal engineers will be out the end of Aug to confirm project estimate. Adam Kulesa from GF&P stated that FLAP Grant funds would be the most effective for project.

<u>BUSH'S LANDING ROAD</u>: Bd discussed Bush's Landing Road. It is in good shape right now. GF&P will send MOU stating that they will contribute 100% necessary funds to chip seal this road & then major maintenance will be at a 75%/25% cost share. County will administer the road project.

<u>LEGAL ISSUES</u>: States Attny Sovell discussed medical marijuana ordinances, court calendar & use of SDLTAP on future road issues.

<u>HWY DEPT</u>: Hwy Supt Schall discussed Waste Tire Clean-up, radio base update, & mowing.
