ADOPT AGENDA: Motion by Richards, second by Shepherd to adopt the agenda. Unanimous vote aye.

PUBLIC COMMENT: No one was present for public comment.

MINUTES: Motion by Floyd, second by Shepherd to approve minutes from the Bd of Commission mtg held on July 8th. Unanimous vote aye.

AMENDED COMMERCIAL DISCRETIONARY FORMULA RESOLUTION: Motion by Richards, second by Floyd to approve resolution. Unanimous vote aye.

**Amended Sully County Resolution No. 2020-19  
Commercial Discretionary Formula**

**WHEREAS, the 2021 South Dakota State Legislature adopted changes to SDCL 10-6 which deals with the Annual Assessment of Property and the South Dakota Department of Revenue deems it necessary to update said resolution; and**

WHEREAS, the County of Sully, State of South Dakota has deemed it in the best interest of the County to adopt a Resolution implementing a Discretionary Formula for the reduced taxation of new structures and additions and partially constructed structures pursuant to SDCL 10-6-13735.2.

NOW, THEREFORE, BE IT RESOLVED, that the following properties shall be, and hereby are, specifically classified for the purpose of taxation pursuant to SDCL § 10-6-13735.2:

Any new commercial structure, or any addition to an existing structure, except a commercial residential structure as described in SDCL § 10-6-13735.2(5), if the new structure or addition has a full and true value of thirty thousand dollars or more (SDCL § 10-6-13735.2(4));

FURTHER RESOLVED, that any structure classified pursuant to this Resolution shall, following construction, initially be valued for taxation purposes in the usual manner, and that value shall be referred to in this Resolution as the "Pre-Adjustment Value"; and be it

FURTHER RESOLVED, that the assessed value to be used for tax purposes of any structure classified pursuant to this Resolution shall, following construction, be calculated as follows:

- a. For the first tax year following construction, 20% of the Pre-Adjustment Value;
- b. For the second tax year the following construction, 40% of the Pre-Adjustment Value;
- c. For the third tax year following construction, 60% of the Pre-Adjustment Value;
- d. For the fourth tax year following construction, 80% of the Pre-Adjustment Value;
- e. For the fifth tax year following construction, 100% of the Pre-Adjustment Value;

and be it

FURTHER RESOLVED, that the Board of County Commissioners may, if requested by the owner of any of the above described property, not apply the above formula, in which case the full assessment shall be made without application of the formula. In waiving this formula for the structure of one owner, the Board of County Commissioners is not prohibited from applying the formula for subsequent new structures by that owner; and be it

FURTHER RESOLVED, that for purpose of this Resolution, the assessed valuation during any of the five years may not be less than the assessed valuation of the property year preceding the first year of the tax years following construction; and be it

FURTHER RESOLVED, that any structure that is partially constructed on the assessment date may be valued for tax purposes pursuant to this Resolution and the valuation may not be less than the assessed valuation of the property in the year preceding the beginning of construction; and be it

FURTHER RESOLVED, that following the five-year period under this section, the property shall be assessed at the same percentage as is all other property for tax purposes.

AMENDED DEVELOPER'S DISCRETIONARY FORMULA RESOLUTION: Motion by Floyd, second by Yackley to approve resolution. Unanimous vote aye.

**Amended Sully County Resolution No. 2020-20  
Developer's Discretionary Formula**

**WHEREAS, the 2021 South Dakota State Legislature adopted changes to SDCL 10-6 which deals with the Annual Assessment of Property and the South Dakota Department of Revenue deems it necessary to update said resolution; and**

WHEREAS, the County of Sully, State of South Dakota has deemed it in the best interest of the County to adopt a Resolution for assessed value to be used for tax purposes on certain residential properties as described in SDCL 10-6-14366.

NOW, THEREFORE, BE IT RESOLVED, that the following properties which can be valued according to this resolution shall meet each of the following conditions:

1. Property must be real property, platted after the effective date of this resolution, zoned for residential construction, and improved with necessary infrastructure to allow for future residential construction.
2. Property must be owned by the person or corporation developing the real property.

The Sully County Board of County Commissioners hereby adopts the following formula under authority of SDCL 10-6-14467.

For the first 5 (five) years following the filing of the plat for the subdivision, the assessed value of lots that remain unsold and having no building construction started on them shall be assessed as follows:

- f. For the first tax year following platting, 20% of full and true value;
- g. For the second tax year following platting, 40% of full and true value;
- h. For the third tax year following platting, 60% of full and true value;
- i. For the fourth tax year following platting, 80% of full and true value;
- j. For the fifth tax year following platting, 100% of full and true value;

Nothing in this resolution is intended to allow any refund or abatement of taxes levied prior to its passage. Also, if requested by the property owner, the discretionary formula may be waived and the full assessment shall be applied.

ORDINANCE#2008-01

(amendments – 2014 – 2021 (removed sections ~~stricken~~; additions **bold and underscored** for publication of changes and emphasis)

Whereas, the Sully County Board of Commissioners have the authority to establish speed zones within their jurisdiction, BE IT ORDAINED, by the board of Commissioners of Sully County, that the following speed zones are established and that those speed zones shall supersede and replace all previously established speed zones,

1. Beginning at the intersection of South Dakota Highway 83 and 185<sup>th</sup> St (Referred to as Sully County FA 30) at the NW corner of Section 11, T114N, R77W, thence Easterly 3/10ths of a mile, the speed limit shall be 45 miles per hour; ~~thence 30 miles per hour for 6/10ths of a mile through Onida, thence for the next 10 miles to a point at the NE corner of Section 9, T114N, R75W, the speed limit shall be 65 miles per hour with a speed limit of 40 miles per hour for trucks 10,000 lbs. and over. Beginning near the intersection of US Highway 83 & 185<sup>th</sup> Street heading in an easterly direction for 3/10ths of a mile the speed limit shall be 45 miles per hour;~~ **For 2/10<sup>th</sup> of a mile from the intersection near Ash Avenue (185<sup>th</sup> Street) and 4<sup>th</sup> Street to the intersection near Ash Avenue (185<sup>th</sup> Street) and 5<sup>th</sup> Street the speed limit shall be 30 miles per hour; For 4/10ths a mile from the intersection near Ash Avenue (185<sup>th</sup> Street) and 5<sup>th</sup> Street to the intersection near Ash Avenue (185<sup>th</sup> Street) and 11<sup>th</sup> Street thru Onida the speed limit shall be 20 miles per hour; For the next 10 miles from the intersection near Ash Avenue (185<sup>th</sup> Street) and**

**11<sup>th</sup> Street to the intersection near 185<sup>th</sup> Street and 315<sup>th</sup> Avenue the speed limit shall be 65 miles per hour with a speed limit of 55 miles per hour for trucks 10,000 pounds and over.**

2. Beginning at the intersection of South Dakota Highway 83 and 185th St. (Referred to as Sully County FA 30) at the SE corner of Section 3, T114N, R77W, thence Westerly for 1/2, mile the speed limit shall be 30 miles per hour, thence Westerly 11 ½ miles to a point at the SW corner of Section 2, T114N, R79W, the speed limit shall be 65 miles per hour, with a 55 mile per hour limit for trucks 10,000 lbs. and over.

3. Beginning at the intersection of the SE corner of Section 3, T114N, R80W, to a point at the SW corner of Section 2, T114N, R81W, Westerly 9/10th of a mile on 185th St (Referred to as Sully County 30) the speed limit shall be 55 miles per hour, thence for 1/10th of a mile the speed limit shall be 30 miles per hour, thence Westerly 5.6 miles the speed limit shall be 55 miles per hour. At the intersection of 185th St and 278<sup>th</sup> Ave at a point at the SW corner of Section 2, T114N, R81W Northerly 1 mile to the intersection of 184th St and 27/10th Ave at the NW corner of Section 2, T114N, R81W, and thence Westerly for 7/10th of a mile the speed limit shall be 55 miles per hour. The speed limit for trucks 10,000 lbs and over shall be 40 miles per hour, except in the above listed 1/10th of a mile, the speed limit shall be 30 miles per hour.

4. Beginning at the intersection of South Dakota Highway 83 and 176<sup>th</sup> St. (Referred to as Sully County FA 60) at the SE corner of Section 22, T116N, R77W, thence Westerly 10 miles to a point at the SW corner of Section 19, T116N, R78W, the speed limit shall be 65 miles per hour, with a 55 mile per hour limit for trucks 10,000 lbs and over.

5. Beginning at the intersection of South Dakota Highway 83 and 176th St. (Referred to as Sully County FA 60) at the SW corner of Section 23, T116N, R77W, thence Easterly for 3/10th of a mile at 50 miles per hour, thence for 3/10th of a mile 25 miles per hour, thence for 2/10th of a mile 50 miles per hour, thence for 6 miles to a point at the SE corner of Section 23, T116N, R76W, the speed limit shall be 65 miles per hour, with a 40 mile per hour limit for trucks 10,000 lbs and over.

6. Beginning at the intersection of 185th St. (Referred to as Sully County 30) and 305th Ave. (Referred to as Sully County 41) at the SW corner of Section 1, T114N, R77W, ½ mile Northerly the speed limit shall be 30 miles per hour, thence for 12 ½, miles to the NW corner of Section 1, T116N, R77W, the speed limit shall be 55 miles per hour, and starting at same intersection 1 mile Southerly the speed limit shall be 30 miles per hour, thence for 10 miles to the SW corner of Section 36, T113N, R77W, the speed limit shall be 55 miles per hour.

7. Beginning at the intersection of South Dakota Highway 83 and 186th St. (Referred to as Sully County Area 512) at the SW corner of Section 11, T114N, R77W, thence Easterly for ~~1 mile~~ 4/10ths of a mile, the speed limit shall be ~~35~~ 45 miles per hour; **For 3/10ths of a mile from the intersection near Redwood Avenue (186<sup>th</sup> Street) and 4<sup>th</sup> Street to the railroad crossing the speed limit shall be 30 miles per hour; For 2/10ths of a mile from the railroad crossing to the intersection near Redwood Avenue (186<sup>th</sup> Street) and 11<sup>th</sup> Street the speed limit shall be 20 miles per hour;**

8. Beginning at the intersection of 185th St. (Referred to as Sully County FA 30.) and 321st Ave. (Referred to as Sully County 11.) at the NE corner of Section 9, T114N, R74W, thence Southerly for 11 miles to a point at the SE corner of Section 33, T113N, R74W, the speed limit shall be 55 miles per hour with a speed limit of 40 miles per hour for trucks 10,000 lbs. and over.

9. Beginning at the intersection of 194th St. (Referred to as Sully County 20.) and 324th Ave. (Referred to as the Sully, Hyde County line) at the SE corner of Section 24, T113N, R74W, thence Westerly for 9 miles to a point at the SW corner of Section 22, T113N,

R75W, thence Northerly for 3 miles to a point at the SE corner of Section 4, T113N, R75W, thence Westerly for 11 miles to a point at the SW corner of Section 2, T113N, R77W, and South Dakota Highway 83 the speed limit shall be 55 miles per hour with a speed limit of 40 miles per hour for trucks 10,000 lbs. and over.

10. Beginning at the intersection of 316th Ave. (Referred to as Sully County 21) and 185th St. (Referred to as FA30) at the NE corner of Section 10, T114N, R75W, thence Southerly for 3 miles to a point at the SE corner of Section 22, T114N, R75W, thence 1 mile westerly to a point at the NE corner of Section 28, T114N, R75W, thence 3 miles Southerly to a point at the SE corner of Section 4, T113N, R75W, the speed limit.

11. Beginning near the intersection of 311 Ave. (Referred to as Sully County FA 31.) and 172<sup>nd</sup>. St. (Referred to as Sully, Potter County line Area 315.) in the NE ¼ of section 2, T116N, R76W, thence Southerly for 24 miles to a point near the SE ¼ of section 35, T113N, R76W, the speed limit shall be 55 miles per hour with a speed limit of 40 miles per hour for trucks 10,000 lbs. and over.

**12. Beginning at the intersection of 182<sup>nd</sup> Street and 282<sup>nd</sup> Avenue at the SE corner of Section 20-T115N-R80W, thence Northerly for 1 mile to the NE corner of Section 20-T115N-R80W, the speed limit shall be 35 miles per hour.**

1342. The speed limit on all Sully County primary and Sully County secondary roads, other than those listed above, shall be 55 miles per hour unless posted for construction or otherwise advertised.
