ADOPT AGENDA: Motion by Richards, second by Fanger to adopt the agenda. Unanimous vote ave.

PUBLIC COMMENT: No one was present for public comment.

MINUTES: Motion by Floyd, second by Shepherd to approve minutes from the Bd of Commission mtg held on October 5th. Unanimous vote aye.
