SULLY COUNTY BOARD OF COMMISSIONERS AUGUST 2, 2022

The Board of Sully County Commissioners held their regular scheduled mtg on Tues, August 2, 2022. Chmn Yackley called the mtg to order at 7:30 am. Other members present: William Floyd, Jerry Richards, Caleb Shepherd & Joe Fanger. Also, present were Susan Lamb, Janet Schmahl, JJ Schall, Emily Sovell, Sheila Ring, Danielle Rausch, Russ Ball & Patty McGee.

<u>ADOPT AGENDA</u>: Motion by Floyd, second by Richards to adopt the agenda with the addition of Danielle Rausch-One Day Malt Beverage License. Unanimous vote aye.

PUBLIC COMMENT: No one was present for public comment.

<u>MINUTES</u>: Motion by Shepherd, second by Richards to approve minutes from the Bd of Commission mtg held on July 8th. Unanimous vote aye.

<u>HUNTING PRESERVE LICENSE</u>: Motion by Richards, second by Floyd to approve the renewal of the Hunting Preserve License for Paul Nelson Farm Inc. Unanimous vote aye.

<u>OPERATING TRANSFER</u>: Motion by Richards, second by Yackley to approve an operating transfer from General Fund to Road & Bridge Fund in the amount of \$500,000.00. Unanimous vote aye.

AGAR BRIDGE 60-358040: Hwy Supt Schall has not received a change order for this project yet.

<u>BUSH'S LANDING ROAD</u>: Bd discussed dust condition of road. Hwy Supt Schall will contact SD GF&P to see if they would cover the cost to apply magnesium chloride for approximately 2000' in front of West Prairie Resort.

<u>HWY DEPT</u>: Hwy Supt Schall discussed road signing & cost of destroyed signs, pickup repair & highway striping. <u>HWY DEPT HIRE</u>: Motion by Richards, second by Shepherd to approve the hire of Dustin Volker at \$17.97/hr. Unanimous vote aye.

<u>GRAVEL TRAILER</u>: Hwy Supt Schall informed Bd that there has been a \$4,800.00 surcharge added to the gravel trailer ordered from Hawk Equipment. This will put the trailer over the \$50,000 bid requirement limit. Bd instructed Hwy Supt Schall to advertise for bids with a bid opening date of Sept 6th.

<u>TIRE DISPOSAL</u>: Bd discussed amt of tires that are being dumped illegally at Sully Lake. Bd instructed Hwy Supt Schall to put up signs stating that it is illegal to dump tires on public property. Comr Shepherd will check with Mayor Gruis to see if City of Onida would be able to apply for a tire disposal grant.

ONIDA CEMETERY: Patty McGee discussed Onida Cemetery with Bd. The Cemetery Bd is in the process of opening up the east side of the Cemetery & McGee requested County assistance in building roads. Hwy Sup Schall estimated the cost at \$32,000.00 which includes gravel cost at \$12,000.00. McGee will get an estimate from another contractor. GIS/P&Z BUDGET: P&Z Vice Chairman Russell Ball requested a salary increase of \$3,000.00 for P&Z Administrator Schmahl in lieu of increases for P&Z Bd members. Bd reviewed both budgets.
