OUTSIDE OF DEADWOOD GRANT: Motion by Floyd, second by Richards to accept Outside of Deadwood Grant in the amount of \$10,000 for tuckpointing the NE corner of the Courthouse. Motion carried 4-0. Absent: Shepherd OFFICE OF SCHOOL & PUBLIC LANDS GIS REQUEST: Motion by Floyd, second by Fanger to request payment of \$4,000 for Sully County GIS Data. Roll Call Vote: Floyd-aye, Fanger-aye, Yackley-aye, Richards-aye. Motion carried 4-0. Absent: Shepherd.

SD DEPT OF PUBLIC SAFETY GIS DATA REQUEST: Bd instructed Aud Lamb to request additional information from Dept of Public Safety on proposed use of GIS Data.

<u>HUNTING LODGE ALCOHOL RENEWAL</u>: Motion by Yackley, second by Richards to approve renewal of Paul D. Nelson Farm Hunting Lodge Alcohol License upon receipt of all necessary documentation. Motion carried 4-0. Absent: Shepherd.

Comr Shepherd arrived at 7:55 am

176TH STREET THROUGH AGAR REPAIRS: Kyle Kurth of Brosz Engineering discussed project with Bd. Bd requested that Kurth bring present an estimate at the September 3rd mtg for a mat replacement comparable to 185th Street through Onida. Project will begin at Hwy 83 & proceed to east edge of Agar. Project would be bid this fall for 2025 completion.

185th STREET WEST OF HWY 83: Kyle Kurth presented a preliminary estimate of \$534,450 to Bd for 185th Street west of Onida for ½ mile. Kurth will review estimate following geotechnical core samples & inspection of lined culverts. Kurth will provide Bd with an updated estimate for full depth reclamation with cement treatment at September 3rd mtg. This project would also be bid this fall for 2025 completion. Motion by Shepherd, second by Richards to approve 2 additional geotechnical core samples within 2.5 miles of Onida. Unanimous vote aye.

SLURRY SEAL: Gill Hedman of SDLTAP discussed with Bd advantages of slurry seal vs chip seal. Slurry seal adds

approximately \$14,000 per mile but eliminates the need for a fog seal & provides longer lasting protection to road. SPRING CREEK/COW CREEK SANITARY DISTRICT: Vic & Andrew Utech discussed concerns with Bd on lack of Sully County development being authorized within Sanitary District. There are approximately 743 acres of Sully County land within the Sanitary District of which only 23% is developed while Hughes County has 271 acres of which 90% is developed. The Sanitary District Board currently has 4 Hughes County residents on it & one open position. Motion by Yackley, second by Fanger to authorize States Attny Sovell to review information &, if possible, send letter to Sanitary District Board requiring Sully County Board Members on Board. Unanimous vote aye.

<u>HWY DEPT PURCHASE REQUEST</u>: Hwy Supt Schall requested permission to purchase 2 Handy Hitches for mowing tractors at a cost of \$23,067 each with a delivery time of 6-8 weeks. Motion by Richards, second by Shepherd to approve request. Unanimous vote aye.

<u>HIGHWAY DEPT</u>: Hwy Dept Schall discussed needed digouts & patching to hwys west of Onida & Agar. Motion by Yackley, second by Floyd to allow up repairs up to \$99,999 for each road. Unanimous vote aye.

2025 BUDGET: Bd made necessary cuts of \$1.9 million to balance the 2025 Provisional Budget.

MONTHLY DEPT REPORTS: Bd reviewed monthly dept reports.
